3. Credit History. Windmill is authorized to investigate Purchaser's credit history, either in connection with this application, or if granted, in connection with any later updates or renewals of credit. Windmill may furnish information concerning Purchaser's account to credit reporting agencies and others who, in Windmill's sole discretion, may properly receive such information.

4. Terms of Payment. Unless otherwise agreed in writing, terms of payment are net amount of invoice to be paid on or before 30 days from invoice date.

5. Rights Reserved by Windmill. Windmill reserves the right at any time to suspend credit, change the credit terms, or demand adequate security from Purchaser when, in Windmill's sole opinion, the financial condition of Purchaser so warrants. In the event any billing is not paid when due, payment therefore, regardless of prior terms, will become immediately due and owing. Acceptance by Windmill of less than full payment shall not be construed as a waiver of Windmill's rights hereunder or at law.

6. Finance Charge. A finance charge will be assessed on delinquent accounts at the rate of 18 percent per annum.

7. Litigation Costs. In the event any billing is not paid by Purchaser when due, and Purchaser's delinquent account is referred to an attorney for collection, whether or not suit is brought, Purchaser agrees to pay a reasonable sum as attorney fees, in addition to all costs and expenses of such suit. It is further agreed that in the event suit is instituted to enforce any of Purchaser's obligations hereunder, or to enforce any guarantees contained herein, or any claim arising hereunder, venue of any such suit may be in Pierce County, Washington.

8. Joint and Several Liability. In the event that Purchaser/Applicant herein is a partnership, it is understood and agreed that each and every partner of said partnership and the marital communities consisting of each partner and their respective spouses, if married, are jointly and severally liable for payment to Windmill of all obligations and indebtedness which Purchaser/Applicant has incurred or is under or may occur or be under to Windmill.

9. Guarantee.
